

Family Dollar 2024 Back-to-School Sweepstakes for Teachers Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE ODDS OF WINNING. VOID WHERE PROHIBITED. ONLY CURRENT TEACHERS ARE ELIGIBLE TO WIN. VOID IN RHODE ISLAND, HAWAII, AND ALASKA, AND WHERE PROHIBITED BY LAW.

PROMOTION DATES

The Family Dollar 2024 Back-to-School Sweepstakes for Teachers (the "Promotion") is being administered by Family Dollar Stores, LLC ("Family Dollar"). The Promotion begins at 12:01 AM Eastern Time ("ET") on Sunday, July 7, 2024, and closes at 11:59 PM Eastern Time ("ET") on Saturday, August 31, 2024 (the "Promotion Period"). Entries received other than during the Promotion Period will be disqualified.

ELIGIBILITY

No purchase is necessary to enter or win. The Promotion is void wherever prohibited. All applicable federal, state, and local laws and regulations apply. **Only current teachers are eligible to enter or win.** The Promotion is open only to legal residents of the contiguous forty-eight (48) United States and the District of Columbia, except Rhode Island, who are age eighteen years old (18) or older (or the age of majority in their state of residence, if higher than age 18) as of July 7, 2024. A person who complies with all the eligibility rules shall be referred to as "Entrant." Employees of Family Dollar, Crayola, LLC, and any of their parent companies, subsidiaries, affiliates, licensees, service providers, prize suppliers, agents, advertising or promotion agencies, and those involved in the production, development, implementation or handling of Promotion (collectively, the "Promotion Entities"), and/or the immediate family (parent, child, sibling, or spouse) or household member (whether or not related) of any such employee are not eligible to participate in this Promotion. While this Promotion may be promoted via social media websites, such websites are not affiliated with Promotion Entities. This Promotion is in no way sponsored, endorsed or administered by, or associated with Meta, Facebook, Instagram, X Corp., or any other third-party website or application that might host content where information about this Promotion is published (collectively "Content Hosts"). Non-compliance with these Official Rules shall result in disqualification from the Promotion.

PRIZES

There will be twenty (20) winners who will each receive one (1) \$250 Family Dollar gift card. Each winner is responsible for the reporting and payment of all state, federal, and local taxes applicable to the receipt of a prize. No transfer, assignment, cash redemption, or substitution of a prize is permitted except that Family Dollar reserves the right, in its sole and absolute discretion, to substitute a prize with a prize of comparable or greater value or cash value. In the event that a prize cannot be awarded for any reason, or a winner is not capable of redeeming a prize for any reason, Family Dollar shall not be obligated to award any prize. If, for any reason, more than the stated number of prizes are claimed, Family Dollar reserves the right to award the prizes in such category by random drawing from among eligible prize claimants in such prize category or in a manner to be determined by Family Dollar in its sole and absolute discretion. All decisions of Family Dollar relating to this Promotion will be final. The Total ARV of all prizes to be awarded is \$5,000.

HOW TO ENTER

There are two ways to enter the Promotion:

Entry via Website. On the campaign webpage (<https://www.familydollar.com/family-dollar-2024-back-to-school-sweepstakes-for-teachers/fbp-20240707-1>), an Entrant must provide us with their first and last name, mailing address, phone number, email address, and, for verification purposes, the name of the school where the Entrant is employed as a teacher.

Alternative Method of Entry. Eligible entrants may submit a legible postcard with their first and last name, mailing address, phone number, email address, and, for verification purposes, the name of the school where the Entrant is employed as a teacher to Family Dollar Direct, ATTN: Family Dollar 2024 Back-to-School Teacher Sweepstakes, 500 Volvo Parkway, Chesapeake, VA 23320. The entry must be postmarked by the end of the Promotion Period and received by Family Dollar on or before September 3, 2024. No mechanically reproduced entries permitted. Illegible and/or incomplete entries are void.

Regardless of Entry method, a maximum number of one Entry may be received by any one individual over the course of the Promotion Period. Additional entries received in excess of the maximum number of entries will be

void. All entries become Family Dollar's property and will not be returned or acknowledged. **Limit one Entry per person/e-mail address for the entire Promotion Period.** Customers submitting multiple names and/or multiple email addresses will be disqualified. The award of a prize is contingent upon Entrant complying with all conditions and fulfilling all requirements set forth herein. Entries must include all of the required information as set forth in the submission form and herein or will be deemed ineligible.

WINNER SELECTIONS

Ten (10) potential winners will be selected in a random drawing shortly after the first month of the Promotion Period (on or about August 7, 2024) from among all eligible entries received as of that date, and ten (10) winners will be selected in a random drawing on or about September 3, 2024, from among all eligible entries received as of that date. The drawings for the winners will be conducted by Family Dollar whose decisions shall be final in all matters relating to this Promotion.

In case of a dispute over a participant's identity, the authorized account holder of the e-mail address at the time of entry will be deemed to be the participant. The term "authorized account holder," as used herein, means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted email address. Proof that a potential winner is the authorized e-mail account holder of the email address submitted at the time of entry may be required as a condition of receiving a prize.

The odds of being selected as a potential winner depend on the number of eligible entries received.

Winners will be announced by October 30, 2024. Winning entrants may be subject to additional teacher verification.

HOW TO CLAIM PRIZE

Potential winners will be notified via email through the email address supplied during the Promotion entry and will be asked to provide their full name, age, additional teacher verification, and mailing address within a specific time period. Prizes will be mailed within three (3) weeks of receipt of winner's details. If a potential winner cannot be contacted within three (3) days of the first attempt to contact him/her, or does not respond within the timeframe stated in the notification, such winner will be disqualified, prize will be forfeited, and Family Dollar may select an alternate potential winner in his/her place.

If chosen, you can use your gift card(s) at any Family Dollar store. Plus, your card(s) will never expire, so you can shop on your own terms. All Family Dollar gift card terms and conditions (available at: <https://familydollar.thegiftcardshop.com/faq>), apply to the use of the prizes, and are incorporated herein by reference.

To redeem your gift card(s), simply follow these instructions:

- Present the card to the sales associate at the time of purchase.
- If your purchase exceeds the funds available on your gift card, you will be required to use an additional form of payment to complete your purchase.

PRIVACY AND PUBLICITY

Family Dollar will collect personal data from Entrants, and this information may be used for the purposes of administering the Promotion, publicizing the Promotion (including in connection with the announcement of winners) or Family Dollar, and otherwise in accordance with the Family Dollar Privacy Policy (available at www.familydollar.com/privacy-policy). Unless prohibited by law, participation in the Promotion constitutes each Entrant's consent for Family Dollar to use the Entrant's name (or username), age, hometown, and state of residence for promotional purposes worldwide, in any media now known or later developed, without additional payment or consideration to the Entrant.

NOTICE OF FINANCIAL INCENTIVE

By signing-up for the Promotion, we will ask you to provide your name, phone number, and school email address. Because the Promotion involves the collection of personal information, it might be interpreted as a "financial incentive" program under California Law. While we do not assign a monetary value to the data that we collect, based on our reasonable estimate, the value of your personal information to us is reasonably related to the value of the sweepstakes prize and your chance to win the Promotion. This value is based on the expense of offering

the Promotion to entrants, along with other factors such as whether and to what extent you take advantage (or opt-out) from any offerings, the total number of entrants, and whether we are able to use the data we collect from you.

When entrants participate in the Promotion, you agree to allow Family Dollar and its Promotion-related service providers to collect your personal information and share the information with our service providers, as defined in Family Dollar Privacy Policy (available at www.familydollar.com/privacy-policy), to facilitate participation in the Sweepstakes. GENERAL RELEASE AND WAIVER OF CLAIMS
